186th Board Meeting Proceedings issued on 11-01-2013

Under Sec.49 of the Water (Prevention and Control of Pollution) Act, 1974 and Sec.43 of the Air (Prevention and Control of Pollution) Act, 1981, no court shall take cognizance of any offence under the above Acts except on a complaint made by a Board Officer authorized in this behalf by it.

The Board in its 162th meeting held on 13-02-2007 has authorized Deputy Environmental Officer/Assistant Environmental Officer to file cases on behalf of the Board in the Courts for violations under the Water Act 1974 and Air Act 1981 after obtaining approval from the Chairman.

The present structure at Regional Offices are Headed by Environmental Officers and Deputy Environmental Officer & Assistant Environmental Officers assist him. At present in some of the Regional Offices only Environmental Officer post is filled without DEO & AEOs. The Board in its 186th Meeting held on 28-12-2012 discussed the above subject in details and approved to authorize Environmental officers in addition to Deputy Environmental Officer and Assistant Environmental Officer to file Cases on behalf of the Board in the Courts after obtaining approval from the Chairman.

Therefore, in pursuance of the decision of the Board, the Environmental Officers of the Regional Office is authorized to file cases on behalf of the Board in the Courts after getting approval from the Chairman.

This is in addition to authorization given vide ref (1) to DEO's and AEO's to file criminal cases in the courts after getting approval from the Chairman.
