CIRCULAR

Sub: Implementation of “eSign” online electronic signature service through XGN Software for the applicants & the officers of the Board –reg.,

In order to comply with the action points of EODB i.e., “*online submission of the application without the need to submit physical copy of the application*” the Board has proposed to introduce Aadhaar based ‘eSign’ online electronic signature certificate from Centre for e-Governance, DPAR(IT) for the applicants as well as for the officers of the Board. For using the above ‘eSign’ facility, having an Aadhaar card & mobile number linked to Aadhaar card is mandatory. (The Aadhaar number will not be stored in the database of XGN. It is used to generate OTP only). In order to receive digitally signed online applications & to discontinue the receipt of physical copy of the application forms (hardcopy), it is proposed to introduce receipt of e-signed online application forms through XGN Software in phased manner from December 2018.

Further, to ensure the authenticity of the applicant, it is proposed to insist the applicant to upload the scanned & self attested ID proof with a photograph such as Voters ID/ PAN card/ Passport/ Driving License. It is also proposed to obtain a scanned & signed copy of the authorization letter for the applicant from the Occupier.

The subject was placed before the 222nd Board meeting held on 04-12-2018 and after detailed deliberation, the Board accorded approval to the following;

1. Implementation of Aadhaar based E-sign digital signature for the applicants & officers of the Board.

2. Receiving digitally signed softcopy of the consent/authorization applications from the applicant without hardcopy of the applications.
3. In order to ensure the authenticity of the applicant, to insist the applicant to upload the scanned & self attested photo ID proof such as Voters ID/ PAN card/ Passport/ Driving License.
4. To obtain a scanned & signed copy of the authorization form for the applicant from the occupier (in case of occupier not applying directly)
5. To accept all documents uploaded in the XGN along with application which are self attested by the occupier.

All the officers of the Board are hereby informed to strictly adhere to the above without fail.
