Karnataka State Pollution Control Board (KSPCB) is implementing Pollution Control laws such as the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 etc., in the State. As per the provisions of the Water Act, 1974 and the Air Act, 1981, the Board officers are inspecting the industries for verifying the compliance to Pollution Control Laws and the conditions imposed in the Consent under the said laws.

Now, under the **Business Reforms Action Plan-2017 of Ease of Doing Business**, the industries can have the Compliance inspections replaced with third party inspection conducted by empanelled list of agencies. In this regard, subject was placed in the 218th Board meeting held on 26.03.2018 vide reference (2) & as per the proceedings, letter vide reference (3) was addressed to various organizations indicating the criteria for empanelment. Subsequently, the issue was discussed during the 219th Board meeting held on 13.06.2018 (reference 4) and resolved to amend the eligibility criteria for empanelment by including the private firms/ companies/ entities/ trust/ proprietorship firms who possesses required and necessary MOEF & CC recognition/ NABL accreditation to take part in empanelment of third party inspections of Orange category industries/ Organizations.

In view of the above, the criteria indicated in the letter cited at reference (3) may be read as below;

b) The team shall be headed by a leader with 2-3 members. The team leader should possess a minimum qualification of M-Tech/ ME/ Ph.D in Environmental Engineering/ Chemical Engineering/ Environmental Science with 10 years or more experience & members should possess minimum qualification of M-Tech/M.Sc in Environmental Engineering/ Chemical Engineering/ Environmental Science with 5 years or more experience.	b) The team shall be headed by a leader with 2-3 members. The team leader should possess a minimum qualification of M-Tech/ ME/ Ph.D in Environmental Engineering/ Chemical Engineering/ Environmental Science with 10 years or more experience & members should possess minimum qualification of M-Tech/M.Sc in Environmental Engineering/ Chemical Engineering/ Environmental Science with 5 years or more experience.
c) The organizations must have MoEF/ NABL approved Laboratory with facilities to carry out sampling and analysis of effluent, air emission & Solid waste or having tie up with MoEF/ NABL approved laboratory.	c) The organizations must have MoEF/ NABL approved Laboratory with facilities to carry out sampling and analysis of effluent, air emission & Solid waste or having tie up with MoEF/ NABL approved laboratory.

In this regard, if your organization is fulfilling the above criteria for empanelment and agreeable to other criteria indicated in the letter cited at reference (3) (copy enclosed), willingness in the prescribed format (Annexure-I & II) shall be sent to the undersigned within 15 days time.

All other criteria indicated in the letter cited at reference (3) will remain unaltered.

With reference to the above subject, it is to be informed that Karnataka State Pollution Control Board (KSPCB) is implementing Pollution Control laws such as the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 etc., in the State. As per the provisions of the Water Act, 1974 and the Air Act, 1981, the Board officers are inspecting the industries for verifying the compliance to Pollution Control Laws and the conditions imposed in the Consent under the said laws.

Now, under the **Business Reforms Action Plan-2017 of Ease of Doing Business**, the industries can have the Compliance inspections replaced with third party inspection conducted by empanelled list of agencies. In this regard, the Board has proposed to identify Central/ State Government organizations/ Institutions to carryout third party inspections.

The Eligibility criteria (approved by the Board) for empanelment of the Organization for third party inspection of Orange category of units;

- a) State Universities/National Institute of Technology/ Engineering Colleges/ Environmental research societies (Government Registered) working in Karnataka for past 10 years and shall have expertise in Environmental Engineering/ Chemical Engineering/ Environmental Science.
- b) The team shall be headed by a leader with 2-3 members. The team leader should possess a minimum qualification of M-Tech/ ME/ Ph.D in Environmental Engineering/ Chemical Engineering/ Environmental Science with 10 years or more experience & members should possess minimum qualification of M-Tech/M.Sc in Environmental Engineering/ Chemical Engineering/ Environmental Science with 5 years or more experience.
- c) The organizations must have MoEF/ NABL approved Laboratory with facilities to carry out sampling and analysis of effluent, air emission & Solid waste or having tie up with MoEF/ NABL approved laboratory.

Other Criteria:

- Orange category organization/Industry, willing to get the third party inspection and certification done instead of inspection by the Board officials, then such organizations need to pay the inspection & monitoring charges to the third party empanelled by the Board.
- The Board will publish sectors of Orange category organizations which can be inspected by the third party.
- The third party inspection will be once in 5 years during consented period before renewal.
- It is not compulsory for the Orange category organizations to undergo the third party inspection. It is only an alternative process and will be carried out only on obtaining the willingness of the Orange category organization.
- The charges for units (to be borne by the Orange category units) who opt for third party Inspection & Certification are as under;
