PREAMBLE:-

The Project Proponent had proposed to undertake quarrying of ordinary sand in government land in Tungabhadra river bed with capacity 147113 TPA over an lease area of 20.23 Acres located at Sy. No. 551(P), Mannuru Suguru village , Siruguppa(tq) Ballari district .

The project proponent is required to obtain Environmental Clearance as per the Environment Impact Assessment Notification dated 14.09.2006 (as amended till 01.12.2009) issued under the Environment (Protection) Act, 1986 notified by the Ministry of Environment, Forest and Climate Change, Government of India.

As the proposed project schedule under EIA Notification 2006 and subsequent amendments made there on. As per the Notification, Environment Clearance is to be obtained from the State Environment Impact Assessment Authority Bangalore (SEIAA).

Accordingly, the Project Proponents have made an application to the State Environment Impact Assessment Authority Bangalore (SEIAA) in prescribed format. The State Environment Impact Assessment Authority Bangalore (SEIAA) authorities after scrutiny of the application made by the project proponents, has issued Terms of Reference (TOR) vide letter No. SEIAA 384 MIN 2021 Dated 20-11-2021. As per the terms of reference issued, conducting of Public Hearing is mandatory.

In order to comply with the TOR, the project proponents have submitted Rapid Environment Impact Assessment(REIA) Report and Executive Summary both in Kannada and English prepared by M/s Mantech Consultants Pvt. Ltd. Noida to The Member Secretary, Karnataka State Pollution Control Board, Bangalore requesting to conduct the Environmental Public Hearing vide their letter dated 21-03-2022.

Considering the request made by the project proponents, Karnataka State Pollution Control Board, Bangalore vide letter Dated 23-05-2022 requested the Deputy Commissioner, Ballari to render suitable date and time for conducting the Environmental Public Hearing.

Further The Deputy Commissioner has given the consent to conduct Environmental Public Hearing on 02-08-2022 at 11.00 am at the project site. The Karnataka State Pollution Control Board published Environmental Public Hearing meeting notice through paper notification in state level newspapers namely "Vijaya Karnataka" (Kannada) and "Decan Herald" (English) on 02-07-2022 in the local Newspaper namely "E Namma Kannada Nadu" on 03-07-2022 by informing the public to submit their objections/suggestions /opinions/ if any with regard to the proposed project within 30 days. (Copies enclosed as Annexure - 3).

In continuation to the above, the Draft Rapid Environmental Impact Assessment Report and copies of the executive summary in Kannada and English were kept in the following places for the information of the public.

All the above departments have been informed about the environmental public meeting and also about the newspaper notification vide letter on 04-07-2022.

In addition, wide publicity was also rendered through public address system and distribution of handbills kept at surrounding villages (M.Suguru ,Muddatanuru,Havinal) of the proposed project area on 29-07-2022. (Photographs are enclosed as **Annexure - 4**).

Deputy Commissioner, Ballari has issued the letter dated: 25-07-2022 to Sri P. S. Manjunatha, KAS (Sr Scale), Additional Deputy Commissioner & Additional District Magistrate, Ballari to conduct public hearing (The copy of letter is enclosed as **Annexure -5**).

After observing the statutory formalities as specified in the Notification, the environmental Public Hearing commenced on 02-8-2022 at 11.00 AM under the Chairmanship of Sri P. S. Manjunatha, KAS (Sr Scale), Additional Deputy Commissioner & Additional District Magistrate, Ballari at the proposed project site located at Sy.No 551(Part) Mannuru Suguru Village , Siruguppa(tq) Ballari district

Dr Doddashanaiah, Member Convener of the Public Hearing Committee, Environmental Officer, KSPCB, Ballari and Senior Environmental Officer (I/c), Zonal Office, Ballari welcomed Sri P .S. Manjunatha, KAS (Sr Scale), Additional Deputy Commissioner & Additional District Magistrate, Ballari. He also welcomed Government Officers, officers of the M/s KSMCL, General public & press representatives and he informed the provisions of the Environment Impact Assessment Notification dated 14-09-2006 issued under the Environment (Protection) Act, 1986. It was informed that the proposed Project Proponents have to obtain Environmental Clearance and also informed that all required procedure mentioned in the Environmental Impact Assessment Notification 2006(as amended till 2009) before conducting public hearing have been followed with. Further he requested Sri P .S. Manjunatha, KAS (Sr Scale), Additional Deputy Commissioner & Additional District Magistrate, Ballari to chair the meeting and to conduct the process of public hearing.

Sri P. S. Manjunatha, KAS (Sr Scale), Additional Deputy Commissioner & Additional District Magistrate, Ballari has addressed the gathering and briefed about the provisions of the Environment Impact Assessment Notification dated 14.09.2006. He also informed that all the oral & written statements will be recorded in the proceedings in Kannada & English. Further, the chairperson of the Public Hearing Panel informed the project proponent to present the technical details of the proposed project.

Accordingly, on behalf of M/s Karnataka State Minerals Corporation Limited. Smt. Binutha has explained the details with respect to Rapid Environmental Impact Assessment Report prepared by Mantech Consultants Pvt. Ltd.,Noida which is comprising of Study area Map, salient features of the site, land use details, infrastructure demands, rain water management, the environmental aspects viz., land, water, noise, environment, economic and financial status, environment management plan,

environment management programme, income, expenditure and total environment management plan and briefed about the CSR activities through power point presentation.


After the presentation, The Chairperson of the Environmental Public hearing panel requested the public gathered at the meeting to express their views/opinions/objections/Suggestions if any and informed to restrict their views to environmental issues only.

Accordingly, the public expressed their views/opinions/objections/Suggestions as below:-

1. **Shri.Basavannai M.Suguru Village-** Speaking on the occasion he asked that whether sand is available free of charge for building a house in his village or should we pay money to buy it. He pleaded for an exemption to get sand as there is a river in his village. He requested that if sand is given free for the construction of the temple in his village, it would be beneficial. He said that whenever the wind comes sand will enter into the village therefore must be prevented from becoming airborne and also requested to recruit employees from his village only.
2. **Shri.Veeresh M.Suguru Village:** Speaking on the occasion, he requested to give jobs to youths of his village.
3. **Shri.G M Parashuram M.Suguru Village:** Speaking on the occasion, many farmers have already paid one and a half lakhs and bought bullocks and carts for sand transport and family also depends on this income, so he requested to facilitate the transportation of sand through bullocks. He requested to arrange sand for building their houses in his village.

The Chairman of the public Hearing Sri P .S. Manjunatha, KAS (Sr Scale), Additional Deputy Commissioner & Additional District Magistrate, Ballari District in his presidential address informed to the public that, No decisions will be made in the Public hearing, all the oral and written statements will be recorded in the Proceedings in Kannada and English. The same will be forwarded to the Member Secretary, Karnataka state Pollution Control Board, Bangalore along with photographs (taken during public hearing is enclosed as Annexure-6) and Video (Documents enclosed as Annexure-7) so as to forward the same to the competent Authority for further necessary action.


He rendered vote of thanks for gathering and the Public Hearing is completed.
